Penalties assessed for failure to file or pay taxes can be excused upon a showing of "reasonable cause and lack of willful neglect." See IRC 6651(a)(2) and Treas. Reg. 301.6651. A failure to file a return or pay tax due within the time prescribed will be considered to be due to reasonable cause to the extent that the taxpayer has made a satisfactory showing that they exercised ordinary business care and prudence. Reg. 301.6651-1(c)(1). The court in Orient Investment and Finance Co. v. Commissioner, 36 AFTR 818, 166 F.2d 601 (1948) stated that "reasonable cause means nothing more than the exercise of ordinary business care and prudence." Reasonable cause is based on all the facts and circumstances in each situation and allows the IRS to provide relief from a penalty that would otherwise apply. Reasonable cause relief is generally granted when the taxpayer exercised ordinary business care and prudence in determining his or her tax obligations but was nevertheless unable to comply with those obligations. See Internal Revenue Manual section 20.1.1.3.2(1). Ordinary business care and prudence is established when a taxpayer makes provisions for their tax obligations based upon reasonably foreseeable events. The Taxpayer can demonstrate they acted with ordinary business care and prudence if they can show legitimate reasons for any non-compliance. See Internal Revenue Manual section 20.1.1.3.2. To show ordinary business care and prudence a taxpayer should provide an explanation that corresponds with the dates of non-compliance. A taxpayer can also demonstrate ordinary business care and prudence by demonstrating that they have a history of compliance with the tax laws. Lastly, if a taxpayer can show that circumstances were beyond their control and they could not have reasonably anticipated an event that led to non-compliance, they have demonstrated that they acted with ordinary business care and prudence. See Internal Revenue Manual section 20.1.1.3.2.2. During the year 2017, Puerto Rico had been affected by two of the most devastating natural hurricanes in the United States history, Hurricanes Irma and Maria. The Organization started its operations in such year. As a result of the natural disasters, the overall power grid in Puerto Rico was damaged and destroyed, and the supplies of basic food and raw materials, gas and diesel, beside others, was limited. It is of public knowledge that most of the business in Puerto Rico suffered extensive damages and mostly remained closed for an undetermined time after the natural disaster. Also, as of todays date, the power electric grid continues to be weaker than ever, a lot of business had not been able to recuperate from the disasters and have been obligated to close. Similarly, most of the funds form the federal government in response to the disaster are pending to approval while we continue striving into the poverty and the aftermath of the Hurricanes. Our Organization is a small one, and mainly was created to help a vulnerable community of people, but with such disasters our focus was placed in helping the community and be able to obtain the necessary help during such tremendous disasters. The Organization clearly, had no intention of disobeying the taxing statutes. The facts showed above, demonstrate that our business have exercised ordinary business care, but such a devastating event could not be prevented, nor anticipated. An assessment of such a penalty for late filling will affect our purpose and the community we helping and may significate that the Organization may need to close, leaving unattended such an increasing and important community. Notwithstanding, as we are committed to comply with our obligations with the IRS we had taken the necessary steps to prevent such delay in the filling of the returns, such as contracting and independent accountant, beside others.
